**Socks Must Be Worn To Play at The Maine Jump**

In consideration of being allowed to enter into the play center and/or participate in any parties or programs at The Maine Jump, the undersigned, on his or her own behalf and on the behalf of the minor(s) identified below and any other minor(s) accompanying the undersigned whether or not listed, acknowledge, appreciate and agrees that:

- Inflatables can be hazardous and dangerous. Activities require strenuous exercise and various degrees of skill and expertise. I understand that these activities can result in serious injury to the person or child. I, on my own behalf and on behalf of my child and any other accompanying minor(s) assume any and all risk and damage or injury while on The Maine Jump premises.
- I am aware of the risk, hazards and danger of personal injury, disability and/or death as a result of participation at The Maine Jump, including those that may arise out of negligence or conduct of other participants. Also, if I discover any hazard during our participation, I will bring it to the attention of the nearest Maine Jump employee immediately.
- I have received and read a copy of the operational rules and understand that is my responsibility to ask questions about the operational rules and regulations if necessary. I understand that it is my responsibility to ensure that I/my children understand the rules. Although there are staff members to monitor children/adults playing, it is my responsibility to supervise and monitor my children and my own activities. I will bring any observation of the rules being broken to the attention of a Maine Jump staff member. I certify that I and/or my child are in good health and that I and or my child have no physical limitations which would preclude safe participation at The Maine Jump.
- In consideration for the admission of my child, I hereby release, waive and forever discharge and covenant not to sue Hatch Family Enterprises LLC., d/b/a The Maine Jump, and its owners, employees, officers, directors, trustees and all other persons or entities acting on its behalf, from any and all claims, actions, damages, liability, cost or expense including attorney fees which are related to or arise out of or in any way connected to my child's and any other minor(s) participation or use of the facility.
- By the execution of this agreement, it is my intention to assume all risk of injury and do hereby surrender and waive any rights to sue or exercise any legal right to seek damages against Hatch Family Enterprises, LLC., d/b/a The Maine Jump, its owners, agents, employees, officers, directors and/or all other persons or entities acting on its behalf.
- I acknowledge that my or my child's and any other accompanying minor(s) participation in activities at The Maine Jump is strictly voluntary. I hereby certify that I'm over 18 years of age, I have carefully read the foregoing release, waivers, and covenant not to sue and acknowledge that I understand and agree to all of the above terms and conditions. Prior to signing this agreement, I have had my opportunity to ask any and all questions. I am aware that by signing this agreement, I, on my own behalf and on the behalf of my child and any accompanying minor(s), assume all risks and waive and release all substantial rights that I, or my child or any accompanying minor(s), may have and possess.

- On all slides, kids must slide feet first and on their bottoms
- No running, pushing or shoving
- No wrestling or rough play
- No diving, climbing, hanging or flips
- Parents must supervise kids at all times
- ONLY KIDS 12 YEARS AND YOUNGER ALLOWED ON JUMPS
- Adults are restricted from playing on jumps unless assisting children age 4 and under.
